
Welcome to the March edition of HDC's Town & Parish Council Newsletter.

Elections – 2 May 2024



The District Council is holding the scheduled Police and Crime Commissioner election on Thursday, 2 May 2024.

As this will be the first scheduled election in the District using voter ID, and in preparation for this, please see **attached** a poster for display on your notice boards to help inform residents of this new requirement that they now need photo ID when voting at a polling station. If you do not have the facility to print the poster, please let **elections@huntingdonshire.gov. uk** know and we can arrange for hard copies to be posted out to you.

Level of Fixed Penalty Notices for Fly-tipping and Littering to be Increased from 1 April 2024

The Community Protection and Enforcement Team are set to increase the level of fixed penalty notices for fly-tipping and littering from 1 April 2024.

or £200 for a large waste item (bin bag size).

- Fly-tipping FPNs will be set at £400 for an amount of waste up to the volume of a car boot, £700 for an amount of waste to the volume of a panel van and £1000 for a large amount of waste, or where we believe the fly tipped waste was obtained commercially (Facebook man-in-a-van waste clearance).
- We are also increasing the FPN amount for household duty of care offences to £400. This is where a person has failed to ensure their waste was legally transferred to an authorised person.
- All of these FPNs will come with a 28 day payment window, with a discount of 25% is paid within 14 days.

The Community Protection and Enforcement Team would be grateful if Town & Parish Councils could help communicate the above points to their residents, and prompt them to report incidents where they witness littering or fly-tipping, especially if they note vehicle details (such as seeing a person litter from a vehicle).



Garden Waste Subscription Service

The early bird discount may have ended, but you can still subscribe to have your garden waste collected after April 1st. Visit the HDC website to subscribe <u>https://www.huntingdonshire.gov.uk/bins-waste/garden-waste-subscription-service/</u>



Starting from 31st March the current free garden waste collection service will be replaced by a subscription service provided by HDC. This subscription service offers residents the option to pay £57.50 (for their first bin and £30 for additional bins) annually to have their garden waste removed.

It is important to note that this is an opt-in service, which means residents will not be automatically charged or subscribed to the service. To subscribe to the service, residents can visit the HDC website or call 01480 388584 at any time. As a close working partner of ours, we seek your support in raising awareness among residents about this change in our garden waste collection service.

Introduction to the Cambridgeshire Rural Affordable Housing Partnership

HDC's Housing Strategy team works closely with Cambridgeshire ACRE to consider providing Rural Exception Housing. In turn, Cambridgeshire ACRE facilitates the Cambridgeshire Rural Affordable Housing Partnership.



The partnership consists of 4 local authorities; Huntingdonshire, South Cambridgeshire, East Cambridgeshire and Fenland District Councils, and 7 housing associations, with a joint aim of delivering affordable housing in Cambridgeshire's rural communities.

Market Towns Programme Update

Vibrant Communities

In the past year, we have delivered the Vibrant Communities scheme in collaboration with the CPCA and DLUHC as part of the wider UK Shared Prosperity Fund. Fourteen town and parish councils across Huntingdonshire have received between £5,000 and £20,000 to deliver new events, expand existing ones, or provide advertising and marketing support for local businesses. The purpose of this fund is to help our towns and large village centres become more vibrant places.

Since April 2023, over forty different events and activities have been delivered using the funding, increasing foot fall to town and village centres, promoting local businesses, and increasing residents' pride in their town and village centres.

Shop Front Grant scheme

The Shop Front Grant scheme launched in Huntingdon and St Ives in June. We are working with Huntingdon BID to deliver the scheme to our local businesses, and in January the scheme was extended to include St Neots and Ramsey.

The scheme is open to independent town centre businesses looking to upgrade or refresh their shop fronts, or make accessibility improvements, with grants of up to $\pm 10,000$ (less VAT) available. Applicants are required to complete the online application form on our website, provide details of the proposed scheme and three quotes for the works, and evidence landlord permission for the work to be undertaken.



Since the start of the scheme we have approved 16 grants across Huntingdon and St Ives, with 9 already completed and paid. Following the scheme launch in St Neots we have received 9 applications which will be formally reviewed in March. We have been really pleased with the uptake of the scheme so far, and feedback from applicants has been very positive.

Users can search for offices, labs, industrial units, shops, pubs, hotels, or restaurants, in addition to available development land.


This initiative aims to simplify the property search process, providing a centralised hub for businesses to make their move to Huntingdonshire where they can grow, connect and flourish.

On 12th March we were informed of the resignation of Councillor Richard West as a District Councillor.

Councillor West, who represented Great Paxton Ward, was a serving Councillor for 18 years since 2006, and was elected five times - which I'm sure you'll agree is an amazing achievement.

A Conservative Group Member, Councillor West served in a number of roles on a number of committees. This included; Chair of Employment Committee, Chair of Hinchingbrooke Country Park Joint Group, and Vice-Chair of Overview & Scrutiny (Social Well-Being) Committee.

Councillor West will, however, be best known across the district for his role as Chair of the District Council, which he undertook with the utmost vigour and professionalism.

A Notice of Vacancy was published on the HDC website on 12th March - to trigger an election for this seat, a request needs to be submitted from two electors for the Ward.
